## Newspaper coverage

### Infotrac Newspaper database

A collection of 45 UK newspapers, both national and regional, and several international newspapers, with daily updates and archives back to 1996 for several titles.

Search by subject keyword, date, or newspaper title. To search on a particular newspaper, type in the newspaper's name next to the 'Browse' button on the initial search page, or click on it to browse the list of newspapers, then click on the one(s) you want. Also:

**The Times** - has a law section- type in 'Law Report' in the 'keyword' search for a list of law stories.

**The Guardian** - has law pages in its supplement called G2 in the Tuesday edition.

**The Daily Telegraph** - has Law Reports in the Thursday edition.
